Technology to help administrators ensure a smooth and efficient running of the organization. Information collected by these systems is structured so that the administrators can easily evaluate the institution's current performance vis à vis previous out puts. Most of the colleges of Madhya Pradesh are under the direct control of Department of Higher Education. Our college is also controlled by the Department of Higher Education of Madhya Pradesh Government .Department of Higher Education has developed centrally controlled MIS system through which the information form all the government colleges are collected. The log in and password is provided by the department to each college through which we can also access the portal. The portal of Higher Education has various modules through which the information is collected and the day to day operations are performed. Student Management: Students admission is carried out smoothly by e governance portal of Department of Higher Education e pravesh link. The registration process is operated by MP online agency and the stake holders can use it through kiosk of MP online, established throughout the state. The admitted students get the information on their registered mobile number. Students submit their fee online through the portal available on MP online authorized by Department of Higher Education. The enrollment generation activities are operational on portal of Barkatullah University while the examination related activities are carried out by the college itself. Feedbacks in different fields are obtained by the form generated in house utilizing Google form. The scholarship related activities are conducted through MIS portal of Department of Higher Education. Two scholarships, Jankalyan and Medhavi chhatra are controlled by the Department of Technical Education through the admin login and password provided to us. Employee Management: Staff and faculty related information is collected and stored through e governance portal and IFMIS (Integrated Financial Management Information System) portal. The ER (Electronic

Record) sheet is available on e governance portal in which the detail record of individual is available on a single click. The IFMIS portal provide salary slips along with annual statement with the help of login password made available to all the staff members. ACR (Annual Confidential Report) is also submitted through e governance portal of HED which is presently under process of updation. Account Management: The Account Section is working on latest version of Tally and the fee submission and record maintenance of students is done by softwares. 1.4.2 – How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)

Feedback Obtained

The college has obtained online feedback covering all the aspects directly related to the stakeholders (students, parents, alumni, hostlers, teachers and employers) through Google forms, on varied aspects of curriculum, teachinglearning, evaluation process, college infrastructure, library, canteen, other facilities, administration and management etc. Total feedback obtained: 2,291 from students, 83 from hostellers, 143 from Alumni, 90 from Teachers, 40 from Employers and 3146 responses from parents. After analysis of feedback the responses from students revealed that students are seeking an improvement in washroom facility, canteen, technical training in various courses and trainings in field of self defense. College administration after discussing the matter with concerned committees, renovation of the existing canteen and construction of new washrooms are done along with renovation of existing ones. Under the NSS activity self defense training programme was organised for the students. The responses received from parents also left lot of scope of work for college to reach up to their expectations especially in creating more job oriented programmes for their wards. Feedback obtained from alumni reflects their concern in improvement of infrastructure, ICT facility and placement of students. College has purchased 50 more computers and provided free wi-fi internet facility along with establishing of more smart classes during this academic session. The funds received from RUSA (Rashtriya Uchchatar Shiksha Abhiyan), World Bank and from Chief Minister fund, infrastructure got strengthen resulting in construction of new building for library, Computer lab and indoor Gymnasium. The career guidance cell of college has been asked to organise more and more career fairs and invite various organizations/ industries in college so that students can explore varied job opportunities. College has organised online Industry academia interface so that students had a direct dialogue with CEOs of various industries. The employers response reveals that emphasis is to be given on practical knowledge and suggested the frame work of the syllabus according to the present requirement. Taking their responses in a positive manner college is going to sign more MoUs with various organisation/industries. Syllabus of college is regularly revised by means of conducting Board of Studies every year, in which revision work is taken into consideration by subject experts. Teachers who are not only mentor of students but are also responsible for providing a healthy environment to their students. Outcome of their responses results in need of recording room in music department, increase in ICT facility, conduction of study tours and more industrial training for students. The issues mentioned in responses are materialized by the college administration in the coming session. Study tours will be organised as the funds are available from World Bank however local tours are conducted regularly through Janbhagidari fund of the college. College is also planning to establish a centralised recording room with modern gadgets related to recording.

Students Mentoring System available in the Institution • The College has a core Tutor-Guardian committee with 01 convener and 09 members representing all faculties of the college. The committee manages the work for the Guardianship provided by all the teaching staff for every single student of the College. • Students are divided into groups of 30 to 60, making more than 85 groups in all, in the college. • Every group is mentored by a faculty member. • During the year four meetings were held. A timetable is prepared in advance which includes names of tutor –guardian and name of students. Their group room is allotted in a particular time slot for the meeting. •

During the meeting, a quarterly bulletin 'Samvad-Setu' is read out, which comprises the facilities available in the college, notice to be circulated among students and scholarships being granted in the college. • The tutor-guardian redresses grievances of students and takes care of their well-being in terms of academic growth, regularity and security. • Students' feedback for institutional support service, teaching and learning is also procured and the responses are analyzed. • Students share their personal, financial, academic, social other problems with the tutor-guardian and seek their remedy. • In the session 2019-20 in the pandemic situation the committee through each Tutor-Guardian played a crucial role in interpersonal communication with the students. It worked successfully as a link between Examination Cell of the college and student in order to conduct Open-Book Examination pattern. • Tutor-Guardian helped in collecting tracking records of Ex-students. Remedial Classes are conducted for academically weak students at under graduate level. They get opportunity to attain extra knowledge of subjects through these classes. Faculty of each department is allocated part of syllabus for which all prepare unit wise teaching plan for the entire session. Academic calendar is printed in the daily dairies and followed accordingly. Teachers adhere to the plan, classes are conducted as per the given time-table. Faculty records the classes and portion completed in their daily diaries. Information regarding class, practical or any event is displayed on the notice board. Website of the college is updated timely for the perusal of the stakeholders.

Curriculum Development

Curriculum Development is needed for appropriate selection of syllabus and organisation of learning experiences. It helps in the selection of study to acquire goals and objectives of teaching. With developing age the curriculum needs to be designed and upgraded annually. Revision of the following subjects was done in the session of 2019-20- • 01 B.Sc.(Home Science) Clinical Nutrition/B.Sc. (Clinical Nutrition) • 04 B.Sc. • 01 B.A. • 05 M.A. • 03 M.Sc. (Home Science) Syllabi of different subjects are adopted according to the syllabus proposed by the Central Board Of Studies approved by Department of Higher Education Govt. Of M.P. New topics pertaining to subjects are added

so as to equip the students with latest knowledge of subjects. Teachers make lessons that include simulation, experiments and other activities to deliver curriculum. The institution is open in adopting education programs which focus on improving student in achieving higher goals. Career based, professional courses are encouraged, which would result in good outcomes.

With the commencement of inter disciplinary programs, student intake has substantially arisen. Efforts are made to incorporate important topics covered in various competitive and entrance exams like UPSC, MPPSC, NET, Banking etc. among others. The faculty and students jointly conduct seminars, conference and workshops related to burning issues, to benefit

burning issues, to benefit
communication skills and attain expert
knowledge. This results in networking
with others and also helps to boost and
motivate students. Department of
Political Science organised a seminar
on Relevance of Mahatma Gandhis
thoughts in Present Scenario
(27-28/06/2019). A webinar was also
organised by World Bank on Curricular
Aspects: NAAC criterion- I
(25-26/06/2020) in which 501 scholars
participated.

Library, ICT and Physical Infrastructure / Instrumentation

During the session 3023 books (Rs. 373842/-) were purchased for SC students and 1179 students got benefited. 1609 books (Rs. 199,774/-) were purchased for ST students and the number of benefited students are 447. Students belonging to the SC/ST/OBC category are provided with free books and stationary. 305 new books were purchased during the session. Rs. 172643/- was spent from the UGC Autonomy Grant of 3,00,000/-. Four Journals were added in the session. The Library is equipped 27 computers, 01 Barcode Scanner, 02 LCD projectors and 05 Digital copy printer. The IT cell of the college follows the IT policy of the department of Information and Technology, Govt. of MP. The college has NRC (Network Resource Centre) which provides free network facility to the students. Wi-fi facility is available in a radius of 100 feet around the Principal chamber and it extends to the Central library. Every department has free access to computer, internet and

other required peripherals to prepare teaching learning material. Students have the liberty to visit the library for preparing presentation and projects. Depending upon student-teacher ratio, Human Resource Management the departments place their demands for teaching faculty, which is formally fulfilled by advertisements in the local news paper. The applications are scrutinized by Guest faculty recruitment committee and the list of candidates is declared on Merit basis. According to the rules of the Department of Higher Education Govt. of M.P., the eligible candidates are appointed officially. Training and workshops ensure and enable the faculty to focus more on current and contemporary issues related to Higher Education. It also enables them to engage and update themselves with latest techniques. For various nonteaching post (skilled/non-skilled labor) is hired by funding from the Janbhagidari/Autonomous. According to the rules and guidelines of the Department of Higher Education Govt. of M.P. Admission of Students Online admission is done through the portal of Department of Higher Education, Govt. of Madhya Pradesh (epravesh), follows a procedure of online registration, online and offline verification and online fee payments. The students are given choice of subjects on the portal of e-pravesh. The students seeking admission in UG/PG, register themselves online in the portal and later at the given date come for verification to the college (offline verification). The students pay fees both online and offline. The admission process is carried smoothly by the Admission committee which looks forth into the process with full dexterity. Industry Interaction / Collaboration The World Bank organised academy industry interface on 7th March 2020 with the objective to enhance the opportunities for employment for the students. Delegates/representatives from Trident group of Industries, Peoples group of Industries and VLCC along with 197 students from the college participated and were benefited by the Academia Industry Interface. The

Swami Vivekanand Career Guidance Cell in the college makes consistent efforts to relate companies and hence give opportunities to students in getting employment in companies like Amazon, Azeem Premji, Sagar Group of Institutes, ARTECH, Brainberg (Psychologist), Magnum, Upward Health, IFBI (Institute of Finance Banking Insurance) ICICI etc. The Swami Vivekanand Career Guidance Cell also collaborates with institutions and experts who offer trainings in various skill development fields which enhance the students to either be self-employed or begin startups.

Research and Development

Renowned scholars are invited by all the Departments to deliver lectures so as to upgrade the knowledge of students. Dr Amar Nayak, Professor of Political Science delivered lecture on Research Design (Dated 04/03/2020) sponsored by UGC to the students to enhance their knowledge of research. 139 Research scholars have been registered for the year 2019-20 in various subjects. There are 46 teachers registered as Ph.D. supervisors. 16 Departments are registered as Research Centre of Barkatullah University. 25 scholars have been awarded Ph.D. The institution conducts pre-Ph.D. viva of the Research Scholars which is attended by faculty of various streams and future scholars too, in the presence of Research Committee of the college. Infrastructure is being up-graded to enable Research Scholars to conduct their research smoothly. Laboratories, Library facilities are utilized consistently. Free excess to Wi-Fi, internet and digital library is given to Research Scholars. Linkages and collaborations with other institutions are developed to facilitate the Research Scholars. Initiatives are encouraged by the college to advocate relative funding of research to students and community which in turn transfers the outcome from lab to land.

Examination and Evaluation

The college conducts examination in annual pattern for UG courses and semester pattern for PG courses. In annual pattern students are evaluated through four CCEs and one year end final examination. Out of the four CCEs two are non-traditional and two CCEs

are in traditional pattern. The college assures the progress of its students through formal and informal modes by Continuous Comprehensive Evaluation (CCE). The formal modes are CCE II (traditional), theory examination and Job Oriented Project Work. The nontraditional or informal modes include classroom response, group discussion and quiz in class, Question-Bank, assignments, surprise tests, presentations, scene enactment, Costume Dramatization, Nukkad Natak etc. The entire examination is conducted by the Examination Cell. It is responsible to declare the examination time-table, it conducts the exam and declares the results within two to four weeks of completion of examination. Complete transparency is maintained in evaluation process. For PG classes setting of question paper and evaluation is done by subject experts from outside the parent university. The ratio of examination is 70 main exam and 30 of CCE. In-house printing of question papers, mark-sheets, preparation of answer copies is done by the Examination Cell. The mark-sheets and answer booklets have QR Code.

THE PRACTICE The following activities were conducted to enable the students: To address the mobility needs of students with locomotor disabilities, the college procured two wheelchairs. Out of the two wheelchairs, one wheelchair is in the custody of the watchman at the entrance gate of the college to provide the student with an easy access upon entering the college. Efforts were made to make instructional material available in audio, e-text and other alternative accessible formats in the recording studio of the enabling unit. Faculty members regularly interacted with different stakeholders to lobby for the entitlements and facilities. 10 newly admitted students started their first year in UG and 05 enrolled for their PG Programs. The unit regularly guides the students and interacts with faculty and college staff to address their special needs. For e.g. Bharti Dongre, B.A. II year was facing difficulties due to her allotted classes being on the first floor. This was looked into in stately and the Timetable was amended to shift their classes to the ground floor. It was ascertained that these students participate in various ongoing training programs and workshops organized by the college. Within the college premises, under the institutional social responsibility a space has been provided without any rental charges to set up a photocopier shop to specially challenged person. 5. OBSTACLES FACED AND STRATEGIES ADOPTED Girls with disabilities remain more marginalized and face discrimination in education and employment because of their gender. Higher education institutions are not fully aware of the special needs of such girl students who are aspiring for higher education and cannot realize their dreams for want of barrier free environment, extra inputs and necessary guidance. Considering the above obstacles the HEPSN unit of the college is striving towards its goals. 6. IMPACT OF THE PRACTICE The enabling unit acted as a one stop for students where all the special needs of these students like availability of instructional material in accessible format i.e. audio and etext, regular encouragement, guidance and counseling, regular interaction with college staff and faculty for addressing their day to day problems greatly helped in increasing the confidence level of the students and saw an improvement in their overall performance Furthermore, the highlight of the year was three visually challenged ex-students of the college got selected into

scheme is very advantageous to monitor overall progress of students because it
  makes possible to have one to one interaction with students. Students are
 divided into batches and a professor is assigned for each batch to play the
role of Tutor- Guardian (TG) who works as a friend, philosopher and guide for
 these students. TG keeps the track of every student's activity and record of
 attendance, result, internal assessment, and other information in specially
 designed booklet. TG encourages students to participate in co-curricular and
extra-curricular activities and gives feedback to parents/ guardians. They also
  council the students to solve difficulties encountered not only related to
college but in their personal lives too. In this way teacher acts as a buffer
for students and help them to get acclimatized to the college environment. 3.
 OBJECTIVES To establish a link between students, college parents. To monitor
 overall progress of students during their graduation and post graduation. To
provide guidance to the students to increase their participation and interest
in different activities conducted by the Institute, thus contributing in their
all round development. Identifying weak areas in their personality and working
 for their holistic development. 4. THE PRACTICE The first major event was an
induction programme for all the newly admitted students of the college in which
  they were introduced about the tutor-guardian scheme and the academic and
    infrastructural facilities available to them. Along with the Principal,
Controller Exam cell, Heads of all Departments and Conveners of all Committees
  address and interact with the students. Examination form distribution and
submission is through their respective Tutor guardians. Students Tracking Task
was successfully completed by tutor guardian of the pass out students from the

inviting parents. In this programme parents had face to face communication with
the Principal and the Deans of the four faculties. Samwad-Setu" is a periodical
booklet of the college, which conveys various college activities and available
   facilities. The students are made aware with the contents of this booklet
during the tutor- guardian meetings. 5. OBSTACLES FACED AND STRATEGIES ADOPTED
Every year, the strength of students is increasing as compared to the number of
teaching staff and so the ratio of students per Tutor guardian. Thus making it
difficult for a teacher to manage a huge group. Most of the students come from
very humble socio-economic backgrounds, therefore the attendance of parents is
not up to the satisfaction. The students are also very hesitant to open up and
 share their problems with the tutor-guardians. Many of them do not even have
  cell phone facility and they invariably change their contact number, so it
  makes difficult for the tutor-guardians to disseminate the information. To
overcome above obstacles the guest faculty of the college are also involved in
the Tutor-Guardian Scheme. Parents are encouraged time and again to attend the
  meetings through their wards. The tutor-guardians counsel the students and
create an atmosphere to build their confidence. The IQAC Cell in collaboration
with the IT cell of the college is regularly updating their website and making
  it more useful for all the stakeholders. 6. IMPACT OF THE PRACTICE All the
 tutor-guardians played a crucial role in interpersonal communication with the
```

students. The tutor-guardians played an important role in motivating the students and kept their spirits high during the crucial and difficult days of global pandemic. It worked successfully being a link between the college examination cell, students and parents. All the examination related work eg. Enrollment, exam form distribution submission, admit card distribution and notifications of scholarship etc. all these tasks were smoothly done by tutorguardians. Tracking record of the ex-students was successfully collected. Parents appreciated "Tutor Guardian Summit" the most as they found it a convenient platform to discuss about the problems of their wards with the Principal as well as faculty Deans. 7.
